
## Taking STOCC

(Summarized Totality of Community Circumstances)

### **Marriage Equality Now in Question**

As of January 15th, the Idaho Rep. Heather Scott, R Blanchard, proposing to reconsider the Obergefell v. Hodges decision legally making states not discriminate any couple wanting to get married. They're asking SCOTUS to have the ability to "reject" the decision that "...took the right away from a state to make the decision and that it undermined the right of voters to determine their own state's 'marriage laws'." This is saying the decision has somehow 'overstepped' the state's ability to legislate on their own. Idaho governor's written a 'Joint Memorial' to SCOTUS to ask about the ability to not except the decision. (Idaho Statesman)

State laws regarding same-sex marriage in the United States prior to Obergefell v. Hodges<sup>1</sup>

- Same-sex marriage legal (including by court decision)
- Same-sex marriage ban overturned, decision stayed indefinitely
- Same-sex marriage banned where federal circuit court has found similar bans unconstitutional
- Same-sex marriage banned
- Same-sex marriage legality complicated

### News from the Front

TMH has been working both internally and with a coalition of partner organizations to prepare the defenses as well as we can. We've established a full localization network, strengthened existing community features, and amassed a force of volunteers that have already been put to work on our various lines of effort. We're not going anywhere, and even in the eventuality of a total ban, the fight doesn't stop until the threat is completely gone.

MDCOA: Swift & total ban. This
is only a planning
consideration for the moment &
predicated on little/no
resistance.

MLCOA: Trump admin will attempt to push a ban, but face resistance from community and allied organizations.

Prepare to face more adversity than before. Don't take good news for granted, don't get complacent/apathetic, and be an active part of your own rescue.

#### **HOPE FOR THE BEST**

There is a concerted effort amongst the transgender military/veteran community, allied organizations, and groups affected by adjacent issues. Support will only rally as time goes on.

The community is alive and well. Lean on each other for support.

The last time this was attempted, we were able to win a grandfather clause and stave off the ban for two years.

There are ample resources available to us.

### FIGHT TO BRIDGE THE GAP

Don't give up hope.

Be good to yourselves & each other. It is everyone's responsibility to care for each other and do their part for the good of the community and those to their left & right. You don't have to be in the fight 24/7: take breaks and time to relax/recharge.

Volunteer. There are lines of effort that cover support, outreach, legal, finance, education, medical, etc.

People are already positioning themselves in the ideal places to leverage their networks and their talents to make positive change.

### Message from Amanda Atchley (MMAA):

Modern Military is a national nonprofit organization that serves as a united voice for the LGBTQ+ military and veteran community. Modern Military educates, advocates, and champions the rights and well-being of LGBTQ+ service members, veterans, and their families, as well as people living with HIV. We focus on advocacy, education, and support programs, as well as tracking and addressing discrimination reports.

### **Advocacy**

Modern Military is based in Washington, DC, allowing our staff to meet directly with lawmakers and those writing and implementing policies that impact the LGBTQ+ military and veteran communities. We work closely with other veteran and military service organizations to oppose anti-LGBTQ+ legislation and policies that would negatively impact our community.

#### **Education**

Modern Military's Rainbow Shield program provides in-person and virtual training for companies, military institutions, nonprofit organizations, government agencies, and individuals seeking to increase their understanding of LGBTQ+ and HIV topics through a military and veteran lens. Our organization also publishes the award-winning Modern Military Magazine, dedicated to raising awareness of issues impacting the LGBTQ+ and HIV-positive military community, as well as sharing personal insights into the lives of service members, veterans, families, and allies.

### Support


Modern Military recently launched a mental health and suicide prevention program for veterans, thanks to a generous grant from the VA. This program includes peer-to-peer support, case management services, and resiliency training at no cost to eligible participants. We also offer virtual support meetings and online support communities for LGBTQ+ service members and veterans, parents and partners of transgender service members, and a group for military-affiliated parents and caregivers of LGBTQ+ children (of any age).
