Taking STOCC

(Summarized Totality of Community Circumstances)

• Developments in the last 2 weeks:

BLUF: Injunctions in Shilling and Talbott continue to block enforcement of the 2025 ban, despite aggressive efforts by the admin to overturn the injunctions in the appellate courts and the Supreme Court. In the meantime, the DoD has been compelled to restore gender-affirming medical care for service members. However, the release of a federal report highly critical of gender-affirming care signals a new front in the admin's campaign against trans rights, which is likely to shape future policy and legal battles. The situation is still volatile, with legal protections currently holding under sustained attack.

• Legal and Policy:

Two separate federal court injunctions (Talbott in the DC Circuit and Shilling in the 9th Circuit) block implementation of the purge. These rulings prohibit adverse actions against trans servicemembers and require the DoD to maintain open service and access to care.

The DC Circuit is reviewing the govt's request to stay the Talbott nationwide injunction. The court hasn't ruled yet. The govt will likely file an appeal to SCOTUS if they do. They have already petitioned SCOTUS for a stay of the 9th Circuit injunction, and Lambda's response was filed on 1 May. We expect a response in the next week.

• **DoD Policy:**

In response to the court orders, DoD has reinstated access to gender-affirming care, including surgeries, HRT, voice therapy, and BH. SHCP waivers for civilian care have also resumed, as have DEERS marker changes. DoD has confirmed that no trans personnel will be separated or denied accessions just for being trans while the injunctions are in place.

• Congressional Inquiry:

Senator Tammy Duckworth and other congressional Democrats have demanded a report from the DoD regarding the treatment of trans personnel and the implementation of court orders. No word as of yet on a response.

• Emerging Threat:

On 30 April, the federal Department of Health and Human Services published a 400-page Cass-like report highly critical of gender-affirming care for youth, claiming that there is "insufficient evidence" for current medical practices and recommending severe restrictions. Major medical organizations (including the American Academy of Pediatrics) condemned the report as misleading, unscientific, and politically motivated. While the report doesn't immediately change military or federal policy, we expect it to be weaponized in future legislative, regulatory, and legal efforts to restrict gender-affirming care for both military and civilian populations, both for youth and adults. We are closely watching how the UK military has responded to public pressure from the Cass report, and will report as the situation changes.

• Assessment:

We remain protected by federal injunctions. Open service and access to gender-affirming care are legally required. However, the ongoing appeals and SCOTUS petitions mean these protections could be reversed quickly if higher courts side with the administration. The uncertainty is causing anxiety, disrupting planning, and undermining cohesion for trans personnel and their families. There is a persistent blue-on-blue threat as the admin attempts to weaponize the "voluntary separations" clause of the enjoined ban to drive a wedge in the community between those electing to remain and those wishing to separate. We cannot allow these issues to lead us to mistreat one another.

The uncertainty is causing anxiety, disrupting planning, and undermining cohesion for trans personnel and their families. There is a persistent blue-on-blue threat as the admin attempts to weaponize the "voluntary separations" clause of the enjoined ban to drive a wedge in the community between those electing to remain and those wishing to separate. We cannot allow these issues to lead us to mistreat one another.

Outlook and Recommendations: Short-Term (Next 2-4 weeks)

Watch for DC Circuit and Supreme Court decisions on the pending stay requests. An adverse ruling could allow the ban to be enforced with little notice. The next scheduled court action is in Shilling with the 9th Circuit on 22 May, but a ruling from the other courts could come at any time. Stay alert for new DoD guidance or congressional actions in response to court rulings or the HHS report. Maintain records of all official communications, medical care, and personnel actions. Get everything in writing to the greatest extent possible.

Mid-Term (1-6 Months)

Stay engaged with the community, and with advocacy orgs like TMH and Sparta. The HHS report will likely be cited in future attempts to restrict care or service.

QUEER HISTORY

Christine Jorgensen (30 MAY 1926- 3 MAY 1989)

Born in 1926, Jorgensen became the first American to gain widespread recognition for undergoing male-to-female sex reassignment surgery, at a time when the subject was rarely discussed publicly. After serving in the U.S. military, she returned to New York, increasingly distressed over what she described as a "lack of male physical development." Her self-guided research and consultations with Dr. Joseph Angelo — a connection through her medical assistant studies — introduced her to the possibility of hormone therapy and surgery.

Her original plan was to travel to Sweden, the only country performing such procedures at the time. But a visit to relatives in Copenhagen proved life-changing. There, she met Dr. Christian Hamburger, a Danish endocrinologist and pioneer in the field. Under his care, Jorgensen began hormone replacement therapy and underwent a series of gender-affirming surgeries, beginning with an orchiectomy (removal of the testicles) and later a penectomy. With support from the Danish Minister of Justice and the American ambassador, her passport was legally changed to reflect her new identity.

She later received a vaginoplasty in the United States when the procedure became available, under the supervision of Dr. Angelo and famed sexologist Harry Benjamin. Jorgensen adopted the name Christine in honor of Dr. Hamburger and went on to become a public advocate, writer, and speaker — bringing trans issues to the forefront in a time of silence and stigma.

Christine Jorgensen's courage and visibility helped lay the groundwork for future generations of transgender individuals. Her legacy remains a powerful reminder of the resilience it takes to live authentically — and the importance of making space for every person's journey.

Community Spotlight: First Co-Hosted Town Hall with both TMH and SPARTA

On 26 Apr 25, SPARTA and TMH teamed up to co-host their first joint town hall session allowing members of both communities to hear the latest updates, ask questions, and work together as large community to make it through these trying times. The session started with a memorial for Piper Spencer, a US Coast Guardsman and C-130 mechanics, who tragically passed away on 23 Apr 25. Following the memorial, TMH Staff broke down the current information concerning the DHA Memo reauthorizing nearly all care from Pre-January for service members but not authorizing care for persons under 19. Next, the TMH J2 team discussed the current court situation including updates on both the Shilling and Talbott cases before discussing potential risky events coming from the Trump Administration. These include the DOJ developing strategy for going after GAHC surgeons under the guide of "child mutilation" and a "study" by the CDC and HHS on the detransition rate of transgender people. Finally, the session ended with the typical questions and answer portion where members were able to have their issues heard and receive the best information the community can provide. While there were some minor tech issues, the TMH and SPARTA staff already have plans for mitigation and these continued joint town halls allow both communities to support each other and stand as a united front!
